MINUTES

January 24, 2011 Meeting

Meeting commenced at 12:40pm

I. Welcome

- a. Brian Austin introduced as new Executive Assistant to the Chief State's Attorney. Former Undersecretary to OPM. Will be attending with Judith Rossi for a while until eventually attending in place of her on behalf of the OCSA

II. Annual Report

- a. Chief Fitzgerald requested clarification on the origin of the statement on page 37 that the Commission supports the repeal of mandatory minimums for carrying small amounts of marijuana
 - i. Statement was a recommendation stemming from the conference held in October 2008.
 - ii. Will change the word "recommendations" to "suggestions" and move the comment to the section discussing the conference.
- b. Werner reminded the group that the Latino & Puerto Rican Affairs Commission would like to see two issues addressed by the Disparity Commission and would like for it to be included in the report: to diversify the judicial bench and to have more court interpreters
 - i. Werner will review the report and provide suggested language to be included
 - ii. Judith pointed out that to "higher more bilingual and bicultural staff" is included in the report.
 - iii. Discussion over its inclusion in the report since the issue has not been discussed by the Commission at-length during the reporting period.
 - iv. Could also look to increase diversity of Judicial Selection Commission
 - v. Decided would review the current diversity on the bench to see if disparity exists and if so, by how much?

- c. Will draft a revision and re-submit to Commission members for review

III. Working Group Updates

- a. Education, Training and Cultural Competence Working Group – Tracey Gove
 - i. Tracey provided an update on their work drafting language for jury instruction on implicit bias
 - ii. Members reviewed a draft hand-out
 - iii. Preston recommended the inclusion of the language “racial and ethnic” between “generalizations” and “stereotypes”
 - 1. Discussion over the proposal
 - 2. Commission decided to include the language “racial and ethnic, or other biases”
 - iv. Tracey will revise the instruction and send it to Kay on behalf of the Commission
 - 1. Judith Rossi would like it stated that the OCSA does not make the formal recommendation of language for jury instruction; it is up to Judicial to determine language for instruction.
 - v. Andrew C. made recommendation that the instruction include a hypothetical example for those who may not fully grasp the meaning of the instruction
 - 1. Along with the submitted language will be a suggestion that the Judicial committees would may want to consider drafting an example of implicit bias for the instruction
- b. Media Working Group – Aileen Keays
 - i. Update on recruitment of media representatives. Continue to reach-out to Dave Ward of channel 3.
 - ii. Update on creation of a research team to review media portrayals of minorities
 - 1. Researching potential journalism professors to partner with
- c. Pre-Arrest, Prevention, Diversionary and Community-based Programs Working Group – Ann-Marie DeGraffenreidt
 - i. Aileen and Ann-Marie have been working on drafting survey questions for service providers to identify interventions that are available in various parts of the state
 - 1. Will identify gaps in services including geographical areas in which various services are not available
 - ii. Ann-Marie has also drafted a list of groups to target for survey completion
 - 1. The list was read and feedback requested from members

IV. Summary of “Think Tank” meeting - follow-up from “Achieving the Goals of Criminal Justice: A Role for Mediation”

- a. Event held at Univ. of New Haven discussing restorative justice
- b. Break-out sessions: one focusing on youth and the other on adults
 - i. Youth group wanted to identify restorative justice programs in existence and/or revitalize ones that have fizzled
 - 1. Peer mediators in schools

- c. Chicago school system has implemented peer mediators in school discipline program
 - d. Pillsbury's program in NH was very well-liked but utilized mediation post-arrest
- V. Update on meeting with CT NAACP's Scot Esdaile
 - a. Judge Harper, Deb, Aileen and Preston met with Tamara Lanier (Chief Prob. Officer), Scot Esdaile (CT NAACP) and Scott
 - b. NAACP is very interested in hosting a joint conference with the Commission
 - c. Will continue to meet with them and will report-back progress to the Commission
- VI. Update on the changes in state government – new Governor, new Undersecretary
 - a. Mike Lawlor has taken Brian Austin's old position as Undersecretary
 - b. With the Governor and most of the new government on same page, will likely move toward reducing prison population and more toward restorative justice – more probation/parole programming
 - c. Many criminal justice issues that may have been proposed prior, or not even due to expected Governor veto, now can be pursued
 - d. Judge Shortall will chair the Sentencing Commission to be created Feb. 2011
 - e. Thoughts on revising bail system
 - i. A lot of competition between bail/bondsman so a lot of undercutting
 - ii. Domestic Violence Commission is interested in revising bail/bond system
 - iii. Lawlor is also interested in such an initiative
