May 10, 2021

- I. Welcome**
 - a. Meeting commenced at approximately 2:05pm
- II. Review and approve minutes from March meeting**
 - a. Motion made to approve made by Carleton Giles, seconded by Preston Tisdale and Sharon Cheeks. Approved unanimously via voice-vote.
- III. Presentation by Ken Barone, CT Racial Profiling Prohibition Project**
 - a. 2019 data identified one department that warranted follow-up. This report has not been made public but was shared with the Advisory Board last November. Continue to work on part II of the report which summarizes the follow up work.
 - i. Most drivers were stopped for speeding, then registration, and third for defective lights.
 - b. 2020 traffic stop data was unique, due to COVID.
 - i. 50% reduction in traffic stop compared to prior year. April, traffic stops virtually stopped; whereas usually April is the busiest month for traffic stops due to federal initiatives (e.g., distracted driving, seatbelts, etc.) held annually during the month.
 - c. Disparity in traffic stops has decreased statewide because this is the state's 6th report. Over the past 6 years, the initiative has identified 29 departments as having disparity and then worked with those agencies to dig deeper to identify the causes of that disparity. Following these partnerships, 28 of the 29 adopted policy change(s) based on the findings which led to decreases in disparity. There is a new report that has not yet been made public which summarizes further analysis on the only agency that has not responded in that progressive manner.
